 Injuries from executing strenuous and demanding physical techniques in soccer; Injuries from dryland training including weights, running, and massage; Injuries from grass, turf and other surfaces including bacterial infections and rashes; Injuries resulting from falls to the ground due to uneven or irregular terrain or surfaces; Injuries from collisions with walls and soccer equipment; Injuries resulting from failure to properly use any piece of equipment or from the mechanical failure of any piece of equipment; Spinal cord injuries which may render me permanently paralyzed; Injuries from extreme weather conditions which may result in heatstroke, sunstroke or hypothermia; Injuries from contact, colliding or being struck by other participants, spectators, equipment or vehicles; Injuries resulting from vigorous physical exertion and strenuous cardiovascular workouts; Injuries from exerting and stretching various muscle groups; and Travel to and from competitive events and associated non-competitive events which are an integral part of the organization's activities.
Furthermore, I am aware:
 That injuries sustained in soccer can be severe; That I may experience anxiety while challenging myself during the activities; That I may come into close contact with other participants, including the possibility of accidental and unexpected contact; That my risk of injury is reduced if I follow all rules established for participation; and That my risk of injury increases as I become fatigued.
